# "Energy is Money & Money is Energy" was a Successful Workshop

Over 50 people gathered at the AmericInn in Chamberlain to listen to Ian Mitchell-Innes, a certified educator in Holistic Management. Ian's insights to holistic management were interesting. One of the points that Ian stressed at this workshop was to watch animal performance when managing holistically. Ian says, "Animal performance requires us to look at the whole and manage the complexity of relationships within it." Ian also explained how he uses his cattle as tools on his operation in South Africa. When the cattle need a higher plain of nutrition he keeps them in animal performance mode. When he needs to make some changes to the environment on his ranch he uses them in landscaping mode, where he uses ultra-high stock density grazing to maintain healthy land. Ian also discussed his mineral program. He offers his cattle free choice minerals where the animal can choose from 15 different minerals in the purest form obtainable. Ian said that everything we do should benefit the triple bottom line. It should provide social, financial, and environmental benefits. If we can keep these three things in mind when making holistic decisions, it can lead to better way of life.

#### **Leopold Conservation Award**

Sand County Foundation's (SCF) **Leopold**Conservation Award (LCA) recognizes landowners actively committed to living the legacy of renowned conservationist Aldo Leopold. The LCA is a competitive award offered in a single state and today landowners in seven states (CA, CO, NE, TX, UT, WI and WY) are being recognized for their conservation efforts. As state partners, the South Dakota Cattlemen's Association (SDCA) and the South Dakota Grassland Coalition (SDGC) are working with the Foundation to present the first annual award to a South Dakota landowner in 2010.

By presenting the award during the SDCA's annual convention, the landowner's conservation achievements will be showcased among their peers. The award winner will receive a cash prize of \$10,000 and a Leopold Crystal.

## National Range Judging Contestants Return Home

OKLAHOMA CITY, OK - The Newell FFA Chapter along with the Butte County 4-H team from Newell, SD have returned home after participating in the 59<sup>th</sup> Annual National Land and Range Judging Contest in Oklahoma City, Oklahoma. Six hundred and fifty teenage FFA and 4-H members competed in the contest held May 4-6, according to Trey Lam of Pauls Valley, Oklahoma. Lam is the president of the Oklahoma Association of Conservation Districts, the contest's principal sponsor. The El Reno Federal Corrections Institute hosted the event on its FCI Farms near El Reno on May 6<sup>th</sup>. Redlands Community College hosted the luncheon for participants at its Darlington Agricultural Education Farm near the contest site. Total registration for the event exceeded 860 with coaches, sponsors, officials and group leaders in addition to the contestants.

The FFA and 4-H participating teams qualified for the national event by placing among the top five teams at contests held in their home states. The first


two days of the three day event offered contestants opportunities to visit nearby practice sites to get acquainted with Oklahoma soils and plants with information available from soil experts. The actual contest site remains a secret until contest day, so no one has an unfair advantage. Contestants and coaches gather on contest morning to find out the official contest location. They then travel to the site, with a police escort, in a caravan of over 100 vehicles spanning several miles.

The event ended Thursday night with an awards banquet in the Great Hall of the National Cowboy and Western Heritage Museum. Jeanette Nance, liaison to Oklahoma Gov. Brad Henry, welcomed the participants. National championship trophies were awarded to team and individual winners in each category of the competition including land judging, range judging, and homesite evaluation. Each category included FFA and 4-H.

In the Range Judging 4-H Competition, the Butte County 4-H team brought home the National Championship! JC Seaman placed 2<sup>nd</sup> individually along with Ethan Pauley placing 3<sup>rd</sup>, Blane Hotchkiss placing 4<sup>th</sup> and Kyle Tifft placing 8<sup>th</sup>, respectively. The Newell FFA Range Judging Team placed 9<sup>th</sup> in the nation. Team members included Tyler Swan placing 22<sup>nd</sup>, Morgan Myers placing 34<sup>th</sup>, Cady Olson placing 39<sup>th</sup> and Brodie Shaykett placing 45<sup>th</sup> individually. The teams were coached by TJ Swan, Butte County Extension Educator, Dave Ollila Newell FFA Advisor, Jodie Dunbar, Newell FFA Advisor and Dani Herring, Newell FFA Alumni Supporter.

According to Dave Ollila, Newell FFA Advisor,"These opportunities to study Range Management provide students with skills and understanding of a valuable natural resource that drives the economies of Rural America in the West. Many students will pursue careers which require the knowledge of habitat and range resource management.

In addition to practicing and competing in the range judging contest, the Newell FFA and Butte County 4-H members were able to take in some of the local attractions Oklahoma had to offer. They were able to tour the Oklahoma City Zoo, Oklahoma City National Memorial and Museum, Lazy E Ranch, and the National Cowboy and Western Heritage Museum. Some other activities included go-carts, watching a movie in an IMAX theater, watching a few horse races at Remington Park, and eating at the infamous Braum's! Jack Link's Jerky supplied more than 40 lbs of jerky to be enjoyed by the 10 South Dakota Teams competing in the National Land and Range Competition. Overall, this was an excellent educational opportunity for all!
